1. **SUPERVISION:** All Students will be under the supervision of their Appointed Church Leader and Conference Volunteer(s) at all times.
2. **RESTROOM USE:** All students must be able to use the restroom, without added assistance.
3. **SUBSTANCE/WEAPONS:** No alcohol, tobacco products, illegal drugs, fireworks, lighters/matches, firearms, knives, or any other weapons will be allowed at the COGSERF conference.
4. **MEDICATION:** All medication(s) brought to SERF must be left with the SERF medical personnel.
5. **PARTICIPATION:** All students are expected to attend all youth activities, unless excused by the Youth Director/Leader.
6. **DRESS CODE:** All students and workers must adhere to the dress code. Clothing deemed immodest or inappropriate i.e., tank, strapless, or halter tops/dresses, no short or mid-thigh shorts, nor any see-through clothing will not be allowed at COGSERF. Athletic shoes recommended.
7. **CLEANLINESS:** Are expected to help keep the grounds and facilities areas clean.
8. **BEHAVIOR/CONDUCT:** No profanity, sexual gestures, harassing, inappropriate touching, misconduct, or disrespect to self or others. Any breach of proper conduct or disregard of COGSERF rules will result in Disciplinary action. Serious or repeated infractions will result in dismissal from Youth Activities with Notification of Parents or legal guardian and Pastor.
